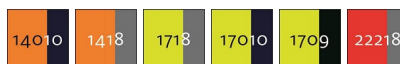

- Durable triple stitched seams on leg and crotch extend product life.
- The surface treatment makes the product dirt-repellent and ensures high visibility.
- Can easily be extended by 3 cm by releasing the red stitching on the inside.
- Kneepad pockets of durable CORDURA® which can be entered from above - closure with hook and loop fastening for easy release, should they get caught on something.
- The dark contrast is placed where the clothing is most exposed to dirt.
- The product tolerates industrial washing.
- Co-certified for use with MASCOT kneepad type SHORT or LONG, as the kneepad pocket is height-adjustable.

### Technical info

Fluorescent and with reflective tape. Two-toned. The surface treatment makes the product dirt-repellent. Triple stitched seams at leg and crotch. Ergonomically formed trouser leg. Adjustable straps with a short and strong elastic and plastic buckles. Braces can be stored away behind the bib using small straps. Large bib pocket with pen opening, phone pocket with zip and flap with hidden press studs. Adjustable waist. Belt loops. Fly with zip. D-ring. Front pockets. Back pockets with reinforcement, flap and hidden press studs. Adjustable hammer loop. Reinforced thigh pocket with additional pockets; an inner phone pocket as well as an external phone pocket with flap and magnetic closure. Ruler pocket with CORDURA® reinforced opening. Adjustable kneepad pockets in durable CORDURA® (500 D) with flap and top access. Vertical reflexes on the side of the legs for better safety. Each standard leg length can be lengthened by 3 cm by releasing the internal red stitching. We recommend 00418-100, 00718-100, 50451-916 and 20118-915 kneepads for this model. Co-certified together with kneepad type SHORT or LONG in accordance with EN 14404.

### Main material/upper material

65% polyester/35% cotton

Twill. Do not soak. Wash separately. The product is certified to retain its properties with 50 domestic washes or 50 industrial washes. The dirt-repellent finish is reactivated by tumble drying according to the washing instructions.

### Logo

The product is certified with a maximum logo area of 0,2100m<sup>2</sup>. This approved area must not be exceeded. Logos respectively on the front or back of the product, can only constitute a maximum of 50% of the total approved logo area in order to maintain the EN ISO 20471-certification. Note: The listed area is only a guide to how much space is available for logo placement. In order to maintain the product's hi-vis class according to EN ISO 20471, the instructions on logo size must be observed.

- Workwear logo. Bib pocket. Max 12x8 cm/4.7x3.1 inches

- Workwear logo. Left back pocket. Max 10x5 cm/3.9x1.9 inches
- Workwear logo. Right back pocket. Max 10x5 cm/3.9x1.9 inches
- Workwear logo. Horizontal on left thigh. Max 9x5 cm/3.5x1.9 inches
- Workwear logo. Vertical on right thigh, read from the top downwards. Max 25x5 cm/9.8x1.9 inches
- Workwear logo. Horizontal on right thigh. Max 11x5 cm/4.3x1.9 inches
- Workwear logo. Above bib pocket. Max 12x2 cm/4.7x0.7 inches
- Workwear logo. Horizontal on left calf. Max 12x6 cm/4.7x2.3 inches
- Workwear logo. Horizontal on right calf. Max 12x6 cm/4.7x2.3 inches
