Elastic and drawstring at waist. Reinforced ruler pocket with a small pocket on the outside. Adjustable polyester kneepad pockets. Simple individual adjustment of kneepad pocket height. Zip with storm flap on outerside of lower legs. Rib inside the bottom by ankles. We recommend 00418-100, 00718-100, 50451-916 and 20118-915 kneepads for this model. Cocertified together with kneepad type SHORT or LONG in accordance with EN 14404.

### Logo

- Workwear logo stretch. Vertical on left thigh, read from the bottom upwards. Max 20x5 cm/7.8x1.9 inches

- Workwear logo stretch. Vertical on right thigh, read from the top downwards. Max 20x5 cm/7.8x1.9 inches
- Workwear logo stretch. Horizontal on right thigh. Max 9X6 cm/3.5x2.3 inches
- Workwear logo stretch. Horizontal on left thigh. Max 9X6 cm/3.5x2.3 inches
