Fluorescent and with vertical and oblique, transverse reflective strips. The fabric is highly durable, breathable, wind and waterproof. CLIMASCOT® Lightweight Insulation. Taped seams. Detachable lined hood with adjustable drawstring. Fastening with zip and double storm flap. Inner pockets - two with zips and one open mesh. Detachable ID card holder. Chest pocket with a zip. Front pockets with a zip. High collar. Rib inside the bottom trim on the front of the jacket. Flap on back of jacket can be folded up for standard back length or released for extended back. Rib (hidden in storm flap) at cuffs. Hook and loop band fastening at cuffs. Zip at lower back for logo printing/ embroidery.

### Logo

Logos respectively on the front or back of the product, can only constitute a maximum of 50% of the total approved logo area in order to maintain the EN ISO 20471-certification. In order to maintain the product's hi-vis class according to EN ISO 20471, the instructions on logo size must be observed.

- Workwear logo. Over left breast pocket. Max 8x3 cm/3.1x1.1 inches
- Workwear logo. Left breast pocket. Max 8x7 cm/3.1x2.7 inches
- Workwear logo stretch. Right breast. Max 8x6 cm/3.1x2.3 inches
- Workwear logo. Over right breast pocket. Max 8x3 cm/3.1x1.1 inches
- Workwear logo stretch. Mid-back. Max 20x20 cm/7.8x7.8 inches
- Workwear logo. Horizontal on right sleeve. Max 10x5 cm/3.9x1.9 inches
- Workwear logo. Horizontal on left sleeve. Max 10x5 cm/3.9x1.9 inches
